 (3) NEW CONSTRUCTION OR NEW ADDITION Rebate Calculation: (LED Watts / (1 - 0.30)) - LED Watts = Watts Reduced (rounded down to zero decimal places). Watts Reduced times \$1 = Rebate Amount. Rebate may not exceed 50% of project cost (excluding labor), up to a total maximum rebate amount determined by Cooperative.

**DOCUMENTATION REQUIRED:** A detailed contractor/vendor quote for pre-approval, an invoice for final application, to include lamp quantities, lamp wattage, type of lamp, lamp manufacturer/model number and project cost (excluding labor), and product spec sheets.

**Project must be completed between July 1, 2016 and June 30, 2017. Final application and required documentation must be submitted to Cooperative no later than June 25, 2017, to be applicable for this program. Funding is limited and based upon availability.**
