

2026 ELECTION: TRUSTEES REELECTED BY AFFIRMATION

**Because no other members submitted petitions to run for the board, no formal election is needed. This saves the co-op mail and election costs. The three incumbent trustees will be reelected by affirmation. Members in Districts 1, 6, and 9 will not receive a ballot to vote in the election.*

District 1: Uncontested

Marion, Madison, Monroe, Preble, and Union Townships in Allen and Adams Counties, Indiana

I have been a Paulding Putnam member 19 years and am retired from iRely. In the past I have served as Vice Chair of the Paulding Putnam Board of Trustees, and have six years of board experience.
