# All board members were present.

## Strategic-Financial-Operation Updates

• Minutes from the February Board Meeting, Re-organizational Meeting, and other consent agenda items were approved as presented. No conflicts of interest were cited.

• The Strategic Planning Meeting will be March 29th.

• The final audit was presented by Mr. Matt Reineck, CPA from the firm Bashore, Reineck, Stoller and Waterman. Mr. Reineck stated the firm was issuing a "clean statement;" there were no material misstatements and the financial report accurately reflected the position of PPEC for the year-end December 31, 2018.

• Board met in Executive Session with Auditor following the final audit presentation.

• There were no injuries for the month of February.

• There were 44 outages for the month of February. Major causes were trees and weather.
